CONDITIONS

This Temporary Certificate authorizes the following persons:

- · the members of Fertilizer Canada and their clients,
- any person using a Fertilizer Canada member-owned tank or a Fertilizer Canada member-leased tank, or
- any person on behalf of the members of Fertilizer Canada,

to handle, offer for transport or transport, by road vehicle, dangerous goods that are UN1005, AMMONIA, ANHYDROUS, Class 2.3(8), in means of containment that do not comply with:

- subparagraph 5.10(1)(a)(iv) of the TDG Regulations,
- specific Requirement 55(a) of Clause 6.3 of CSA B622-14, specifically the 3
 year pressure test requirement,
- specific Requirement 54(c) of Clause 6.3 of CSA B622-14, specifically the 3 year pressure test requirement as referenced in Clause 7 of B620-14, and
- note (10) of Table 7.1 of CSA B620-14, specifically the 3 year pressure test requirement,

if the following conditions are met:

- (a) The means of containment is either a:
 - highway tank, commonly referred to by Fertilizer Canada as a Field Delivery Unit or Transport Delivery Unit (TDU) specified in Specific Requirement 54 of CSA B622-14, or
 - (ii) portable tank, commonly known as a nurse tank or applicator tank, operated exclusively for agricultural purposes specified in Specific Requirement 55 of CSA B622-14;
- (b) The means of containment is selected and used in accordance with CSA B622-14;
- (c) Despite Specific Requirement 55(a) of Clause 6.3 of CSA B622-14 and Note (10) under Table 7.1 of CSA B620-14, the means of containment may undergo a pressure test every five (5) years as previously required in CSA B622-09 and CSA B620-09;
- (d) The means of containment has been subject to an external visual inspection in accordance with CSA B620-14 during the last 12 months;

- (e) In addition to the requirements of Part 6 (Training) of the *Transportation of Dangerous Goods Regulations*, the members of Fertilizer Canada ensure that the personnel handling, offering for transport or transporting the dangerous goods are trained in regards to the conditions of this Temporary Certificate;
- (f) Fertilizer Canada ensures that a paper or electronic copy of this Temporary Certificate is provided to all its members; and
- (g) A paper or electronic copy of this Temporary Certificate accompanies the dangerous goods during transport and must be provided to an inspector immediately upon request.

Note 1: The conditions of this Temporary Certificate must be complied with. Subsection 31(4) of the *Transportation of Dangerous Goods (TDG) Act, 1992* stipulates that non-compliance with any of the terms or conditions invalidates the Temporary Certificate.

Note 2: The issuance of this Temporary Certificate in no way reduces the certificate holder's responsibility to comply with any other requirements of the *Transportation of Dangerous Goods Regulations*, the *Technical Instructions for the Safe Transportation of Dangerous Goods by Air*, the *International Maritime Dangerous Goods Code*, and the *Canadian Aviation Regulations* not specifically addressed in this certificate.

(The following Explanatory Note is for information purposes only and is not part of this certificate.)

Explanatory Note

This Temporary Certificate authorizes the members of Fertilizer Canada and their clients to continue with the 5 year pressure test cycle for their nurse tanks or applicator tanks and delivery units as it was required in CSA B620-09 and CSA B622-09, instead of every 3 years as prescribed in the current CSA B622-14 and CSA B620-14. However, the tanks must still comply with the required annual external visual inspection per the current CSA B620-14. This temporary certificate has been issued for tanks that have not been post weld heat treated.
