## Security Plan Template Now Available in CAN Code Appendices

The Calcium Ammonium Nitrate Security Code of Practice (CAN Security Code) is being implemented over the course of 2019.

The CAN Security Code was created as a proactive approach to expected new regulatory requirements for CAN resulting from the current review of the *Explosives Regulations* by Natural Resources Canada and aims to provide uniform security practices for the handling, transportation, storage and/or sale of CAN in Canada.

#### New Resource Materials Now Available for Security Plans

To assist with the requirements of the CAN Security Code, the CAN Code Appendices is a companion document which provides templates and guidance materials for meeting the requirements of the Code. Fertilizer Canada has revised the CAN Code Appendices to include a security plan template to assist sites in preparing this document.

Natural Resources Canada recommends that a security plan should includes measures and procedures for site security, security breaches and emergencies, access control, stock management, refusal of sale as well as other considerations. In line with these guidelines, this template is designed to provide an example of what a security plan could look like and the types of considerations that should be made when generating a security plan for a site.

#### **Implementation Timelines**

Implementation of the CAN Security Code began January 1, 2019. Fertilizer Canada members must be certified under the CAN Security Code as a condition of membership. Agri-retail and distribution sites who transport, store, handle and/or sell CAN must schedule their formal site audits in order to obtain certification by the mandatory deadline of December 31, 2019.
